Recall Description

General Motors has approved a safety recall in Canada for certain 2014-2018 model year Chevrolet Silverado LD, GMC Sierra LD, 2015-2017 model year Cadillac Escalade, and 2015–2018 model year Chevrolet Suburban, Chevrolet Tahoe, and GMC Yukon vehicles, that, in some circumstances, may have a condition in which the engine-mounted mechanical vacuum pump output may decrease over time, decreasing the amount of vacuum/power brake assist.

Remedy

Dealers are to reprogram the electronic brake control module (EBCM).

Recall Description

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2015 model year Chevrolet Silverado LD, Suburban, and Tahoe vehicles; GMC Sierra LD and Yukon vehicles; Cadillac Escalade vehicles. These vehicles may experience a temporary loss of EPS assist followed by a sudden return of EPS assist, particularly during low-speed turning maneuvers. The loss and sudden return of EPS assist typically happens within a 1 second period and is caused by an electrical/software issue.

Remedy

Dealers will perform a reflash of the EPS module software free of charge.
