Issue: On certain vehicles, brake fluid could leak into the control module for the antilock brake system (ABS) and cause it to short circuit. Safety Risk: A short circuit could create a fire risk, even while the vehicle is parked and turned off. Corrective Actions: Hyundai Canada will notify owners by mail and advise you to take your vehicle to a dealership to replace the fuse for the ABS module.
