Recall Description

The Power Window Master Switch (located on the driver's door) in the above vehicles may have been manufactured with insufficient lubricant grease. If sufficient grease is not applied, under certain conditions the switch may develop a short circuit that can cause the switch assembly to overheat and melt. A melting switch can produce smoke and potentially lead to a fire.

Remedy

The remedy will involve an inspection, switch disassembly, and application of a specialized grease. In a limited number of cases, the electronic circuit board in the Power Window Master Switch will be replaced.

Recall Description

The subject vehicles are equipped with front passenger airbag inflators produced by Takata. The propellant in these inflators may degrade after prolonged exposure to high absolute humidity and fluctuating high temperatures. Degraded propellant can cause inflator rupture during airbag deployment.

Remedy

Any authorized Toyota dealer will replace the airbag inflator.
