### Recall Description

The shifter cable bushing on the transmission end of the shifter cable could deteriorate and become detached from the transmission which could result in the inability of the driver to actually shift the transmission, even though the driver may move the shifter handle.

### Remedy

FCA US will conduct a Voluntary Safety Recall to replace the shift cable adjuster , which contains a more robust bushing, in all of the affected vehicles.
