## Open Recalls

Recall #: CAN241 | 241 - Remedy Notice - Certain 2003-2008 model year Corolla, Matrix, Sequoia, Tundra vehicles - Front Passenger Air Bag Inflator Module

**Recall Description**

The subject vehicles are equipped with front passenger air bag inflators which could have been assembled with improperly manufactured propellant. Improperly manufactured propellant could cause the inflator to rupture and the front passenger air bag to deploy abnormally in the event of a crash, increasing the risk of injury to the occupant.

**Remedy**

Toyota is currently in the process of preparing remedy parts. When the remedy is ready, Toyota will send a follow-up notification, requesting that you make an appointment with your authorized Toyota dealership. At that time, any Toyota dealer will replace the front passenger air bag inflator module for you.
