Recall Description

A loose or detached DAB emblem may result in either the emblem or retainers, or both, not remaining attached to the DAB cover during DAB deployment.

Remedy

The interim repair is to remove the emblem and the emblem retainers from the driver airbag. The final repair is to apply tape to the back of the cover if the emblem is securely attached to the cover. If the emblem is not securely attached, the final remedy is to replace the DAB cover.
