

#### **Recall Description**

CERTAIN 2022-2023 MY MUSTANG VEHICLES DID NOT HAVE THE REMEDY FOR SAFETY RECALL 24S44 24V-493 INSTALLED CORRECTLY ON THEIR VEHICLES BUT WERE RECORDED AS HAVING RECEIVED THE REPAIR SUCCESSFULLY COMPLETED IN FORDS RECORDS. IN THE AFFECTED VEHICLES, THE SECONDARY DIGITAL TORQUE SENSOR IN THE STEERING GEAR WAS ORIGINALLY CALIBRATED WITH AN INVERTED POLARITY. BECAUSE THE CORRECT SOFTWARE UPDATE REMEDY WAS NOT INSTALLED ON THEIR VEHICLE, THE UNDERLYING CONDITION SPECIFIED IN SAFETY RECALL 24S44 24V-493 STILL EXISTS, AND IF THE PRIMARY STEERING TORQUE SENSOR EXPERIENCES A FAILURE OR FAULT AND THE SECONDARY DIGITAL TORQUE SENSORS POLARITY IS INVERTED, THE STEERING WHEEL MAY BEGIN OSCILLATING WITHOUT WARNING ALTERNATING CLOCKWISE COUNTERCLOCKWISE WHEN THE DRIVER ATTEMPTS TO STEER. THE OSCILLATION RESULTS FROM THE ELECTRONIC POWER STEERING GEAR PROVIDING UNINTENDED STEERING ASSIST.
