

The reprogramming will help improve vehicle performance during an evasive double lane-change driving maneuver.

Remedy

Dealers will reprogram the Anti-Lock Braking System (ABS)/Vehicle Dynamic Control (VDC) control unit. This service, which is conducted at no charge to you for parts and labor, should take less than one (1) hour to complete. However, your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

Recall Description

Due to a supplier manufacturing concern that has since been corrected, the Top Tether Anchors of the Lower Anchors and Tethers for CHildren (LATCH) system on the second row rear seat backs may have an insufficient weld condition to the seat back frame. In this condition, the second row Top Tether Anchors may bend or move when a pull force is applied and may not meet the regulatory requirements of FMVSS No. 225.

Remedy

Dealers will inspect the LATCH Top Tether Anchors and replace, if necessary, the second row rear seat backs. The inspection should take less than one (1) hour to complete however, if seat replacement is necessary the repair could take up to three (3) hours. The dealer may require the vehicle for a longer period of time based upon the dealer s work schedule.
