### **Recall Description**

In the involved vehicles, there is a possibility that under certain limited conditions, if the sliding door opening operation is impeded, the sliding door motor circuit could be overloaded, opening the fuse for the motor.

### Remedy

Any authorized Toyota dealer will replace the instrument panel junction block and install new wire harnesses connecting to the power sliding doors. If applicable, the dealer will also update the vehicle Owner's Manual to match the updated equipment.

### **Recall Description**

The subject vehicles are equipped with front passenger airbag inflators produced by Takata. The propellant in these inflators may degrade

after prolonged exposure to high absolute humidity and fluctuating high temperatures. Degraded propellant can cause the inflator to explode during airbag deployment.

#### Remedy

Toyota will replace the airbag inflator or the airbag assembly.
