Recall #: W79 | 2014-2019 WK 3.0L DIESEL EGR COOLER Recall Date: 2020 Nov 19

Recall Description

Thermal fatigue may cause the EGR cooler to crack internally over time. An EGR cooler with an internal crack will introduce pre-heated, vaporized coolant to the EGR system while the engine is running. In certain circumstances, this mixture interacts with other hydrocarbons and air in the system, potentially resulting in combustion within the intake manifold, which may lead to a vehicle fire.

Remedy

FCA US will conduct a voluntary safety recall on all affected vehicles to replace the EGR coolers with a new EGR cooler that is not susceptible to thermal fatigue. In the event the intake manifold is damaged, the intake manifold will be replaced
