Recall #: R1609 | MAX ALT RG MUR OCS NTB16-052 Recall Date: 2016 May 24

Recall Description

The Occupant Classification System (OCS) is designed to classify the size and weight of the front seat passenger and, under certain conditions, automatically turn OFF the passenger air bag. The OCS system is designed to only deploy the front passenger airbag when the front passenger seat is occupied by an adult. In the affected vehicles, the OCS software may incorrectly classify the passenger seat as empty when it is occupied by an adult. If the OCS does not detect an adult occupant in the passenger seat, the passenger airbag would be deactivated.

Remedy

The OCS software will be reprogrammed to reduce the potential for classifying the seat as empty. This reprogram will be offered at no charge to the customer and should take less than an hour to complete. Your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

Recall #: PC459 | ROGUE LIFTGTE STAY NTB16-105 Recall Date: 2016 Nov 08

Recall Description

On certain Model Year 2014-2016 Rogue vehicles, the anti-corrosion treatment on the rear lift gate stays may be insufficient. The rear lift gate stays provide power assist to the rear lift gate and operate under high pressure gas. If the anti-corrosion coating is insufficient, in certain rare instances, the rear lift gate stay may corrode over time due to salt and water penetration; causing a sudden release of pressure.

Remedy

Nissan is currently awaiting parts to remedy the affected vehicles. Nissan will send you a second letter, when parts are available, asking you to bring your vehicle to a Nissan dealer for the remedy at that time. This repair is free of charge for parts and labor. In the meantime, if you believe there is an issue with the rear door stays your vehicle, you may bring your vehicle into the nearest Nissan dealer for inspection.

Recall #: PC490 | ALT RGE CVT P0776 NTB16-121 Recall Date: 2016 Dec 20

Recall Description

Under specific driving conditions, hydraulic pressure may decrease and result in belt slip within the CVT. This may result in MIL illumination. Continuing to drive the vehicle in this condition can lead to accelerated wear and damage to the CVT. Nissan is proactively reprogramming the Transmission Control Module (TCM) with updated CVT software to prevent decreased hydraulic pressure and belt slip from occurring. This is not a safety issue, and the vehicle still meets and/or exceeds all applicable safety standards.

Remedy

To assure your continued satisfaction and confidence in your vehicle, and prevent possible future damage to the CVT, your Nissan dealer will reprogram the Transmission Control Module (TCM) at no charge to you for parts or labor. The service should take less than one (1) hour to complete, but your Nissan dealer may require your vehicle for a longer period of time based upon their work schedule.

Recall #: R21B9 | ROUGE WIRE HARNESS NTB22-076 Recall Date: 2022 Jan 25

Recall Description

IN AFFECTED VEHICLES, IF WATER AND SALT COLLECT IN THE DRIVER S SIDE FOOT WELL, IT MAY WICK UP THE DASH SIDE HARNESS TAPE AND ENTER THE CONNECTOR. IF THIS OCCURS, THE DASH SIDE HARNESS CONNECTOR MAY CORRODE AND POSSIBLY CAUSE ISSUES SUCH AS DRIVER S POWER WINDOW OR POWER SEAT INOPERATIVE, ALL-WHEEL DRIVE (AWD) WARNING LIGHT ON, BATTERY DISCHARGE, AND/OR THERMAL DAMAGE TO THE CONNECTOR. IN RARE CASES, THE CORROSION COULD POTENTIALLY LEAD TO A FIRE, WHICH MAY INCREASE RISK OF INJURY.

Remedy

YOUR NISSAN DEALER WILL INSPECT YOUR VEHICLE AND PERFORM THE APPROPRIATE REPAIR 1) IF CORROSION IS PRESENT ON EITHER THE MAIN HARNESS OR THE BODY HARNESS CONNECTORS, THE DEALER WILL REMOVE THE HARNESS TAPE AND HARNESS COVERING, REPLACE BOTH CONNECTORS AND APPLY WHITE LITHIUM GREASE TO THE CONNECTORS 2) IF CORROSION IS NOT PRESENT ON EITHER OF THE CONNECTORS, THE DEALER WILL REMOVE THE HARNESS TAPE AND HARNESS COVERING AND APPLY WHITE LITHIUM GREASE TO THE CONNECTORS. THIS SERVICE WILL BE CONDUCTED AT NO CHARGE TO YOU FOR PARTS AND LABOR, AND MAY TAKE UP TO TWO (2) HOURS TO

COMPLETE IF YOUR HARNESS CONNECTORS REQUIRE REPLACEMENT. HOWEVER, YOUR NISSAN DEALER MAY REQUIRE YOUR VEHICLE FOR A LONGER PERIOD OF TIME BASED UPON THEIR WORK SCHEDULE.
