**Recall Description**  
 Issue: On certain vehicles, there may be a problem with the driver and front passenger seat belt pretensioners. As a result, the seat belt pretensioners could explode in a crash. If this happens, small pieces of metal could hit people in the vehicle. Note: This recall affects Elantra and Elantra Hybrid models, and replaces recalls R0209 (Transport Canada No. 2022-098) and R0200 (Transport Canada No. 2021-627). Vehicles that were repaired under those recalls also require this repair. Safety Risk: A seat belt pretensioner that explodes could create a risk of injury. Corrective Actions: Hyundai will notify owners by mail and instruct you to bring your vehicle to a dealership to install a protective cap over the driver and front passenger's seat belt pretensioners. Note: Due to limited parts availability, your dealer may not be able to immediately schedule your repair. Hyundai continues to work to obtain sufficient parts to complete all vehicle repairs. Owners will receive individual notifications when when sufficient parts are available.

**Recall Description**  
 Issue: On certain vehicles, the rearview camera may not have been manufactured properly. Over time, the camera could fail and cause the rearview camera image not to display. Canadian regulations require the rearview image to display when the vehicle is reversing. Note: For the Santa Fe model, this recall affects both Santa Fe and Santa Fe Hybrid models. For the Elantra model, this recall affects both Elantra and Elantra Hybrid models. Safety Risk: A rearview camera image that doesn't display could reduce a driver's ability to see behind the vehicle while backing up. This could increase the risk of a crash. Corrective Actions: Hyundai Canada will notify owners in writing and advise you to

take your vehicle to a dealership to replace the rearview camera. Precautions: No precautionary measures are to be taken at this moment; however, if you experience any issues with your vehicle, please contact your dealer immediately.
